



**Typosquatting and Domain Name Dispute Resolution:
A Vindication of the Bundle of Rights Theory?**

ABSTRACT

With the tremendous growth of the use of the Internet for commercial purposes has risen a wide range of challenges far beyond the contemplation of its designers. When a corporate organisation registers its trademark, logo, business name as its domain name, traditional understanding of property law would lead such an organisation into believing that it retains the right to the use of that domain name to the exclusion of any other person or entity. But what happens when someone else deliberately omits, adds or misspells a letter in that domain name and proceeds to register it as a distinct domain name? On what basis would or should the law intervene to protect the interest of the original domain name user? While the related phenomena of cybersquatting and typosquatting have received some considerable attention in scholarly works as well as juridical decisions across various jurisdictions, there remains a paucity of discussion on the underlying philosophical basis for protecting the interests of one party against the other. Beyond the traditional application of Common Law property rights to cases involving cybertrespass in general, this paper particularly accentuates a different legal basis for the protection of proprietary interests against typosquatters. Reflecting on juridical disputes from diverse jurisdictions including South Africa, this paper demonstrates that the bundle of rights theory, an idea that had received much vilification and polarised jurists particularly in Anglo-American legal traditions, provides the most plausible philosophical foundation for

tackling the menace of typosquatting. The paper then investigates what practical significance the application of the bundle of rights theory, among other proprietary concepts, has for the issue of property on the Internet, and in reconceptualising our understanding of the boundaries of proprietary *res* in a distinct environment.

All manuscripts should be word-processed (letter or correspondence-quality font). If the paper has been presented previously at a conference or other professional meeting, this fact, the date, and the sponsoring organization should be given in a footnote on the first page. Funding sources should be acknowledged in the "Acknowledgements" section. Articles published in or under consideration for other journals should not be submitted. Significantly enhanced versions of manuscripts previously published may be considered. Authors need to seek permission from the publishers of such previous publications. Papers awaiting presentation or already presented at conferences must be significantly enhanced (ideally, taking advantage of feedback received at the conference) in order to receive consideration.

The following information applies to both the review and the final version of the manuscript except that the review submission should not include Authors Names section, Biography section, or Acknowledgments section (if it contains information identifying the authors). Please follow review submission system guidelines.

If an article is accepted, author(s) must provide a machine-readable (Word or Word Perfect) version and graphics (figures) in GIF, TIF, or PowerPoint (preferred) format. Permissions for reprinted material are the sole responsibility of the author(s) and must be obtained in writing prior to publication.

Separate line centered; bold, all caps, Times New Roman 16 point ;

- **Author Name(s)**

Separate line centered; bold, Times New Roman 12 point: Do not include author name(s) anywhere else in paper except in bio or reference list as appropriate;

- Phone numbers; • Fax numbers; • E-mail addresses.

- **Keywords**

Begin with heading of "Keywords:" on same line as text, Times New Roman 11 point. Select 5-10 words or phrases to be used for indexing, in consultation with a technical thesaurus, if helpful. These might include important terms from the title, their synonyms, or related words. Do not use prepositions. Do not use hyphens unless the hyphenated parts are always treated as a unit. Use terms that are as specific as possible and whose meaning is generally known.

- **ABSTRACT**

Begin with heading of **ABSTRACT** on a separate line centered over text, bold, all caps, Times New Roman 11 point ;

Abstract body is Times New Roman 11 point ;

REFERENCES

- Sequence: Entries should be ordered alphabetically (in text and Reference section) according to authors' or editors' last names, or the title of the work for items with no author or editor listed. References in text must be included in Reference section and vice versa. References in text should be of the format: (Jones et al. 1995; Smith 1996).
- References to items in periodicals: Author, year, title, journal, volume, number, month, pages. For authors, last names are given first, even for multiple authors.
- References to reports or proceedings: Author's name, year, title of report (same style as above), report number, source, editor and/or publisher as appropriate, city and state/country of publisher OR conference as appropriate, including date and pages.
- References to books: Author's name (same style as above), year, title, publisher, city, state/country, page, or chapter.
